- 2. The Company has also placed the Notice of Postal Ballot on the web site of the Company as well as web site of E-voting platform of NSDL and web site of BSE Limited.
- 3. The Company has published the newspaper advertisement for date and time of commencement and end of remote e-voting and Postal Ballot in;
 - A. Financial Express (Vernacular Language Gujarati) on December 15, 2020 &
 - B. Financial Express (English Language) on December 15, 2020.
- 4. The Shareholders holding Shares as on the "Cut off" date, i.e. Friday, December 11, 2020 were entitled to vote through remote e-voting platform on the business mentioned in the Notice of Postal Ballot of the Company.
- 5. In terms of the aforesaid Notice, remote e-voting was opened for thirty days which commenced on Wednesday, December 16, 2020 (09:00 A.M.) and ended on Thursday, January 14, 2021 (05:00 P.M.) (Both days inclusive) and members of the Company, holding Equity Shares of the Company as on Friday, December 11, 2020, were required to cast their votes electronically, conveying their assent or Dissent in respect of the special business mentioned in the Notice of Postal Ballot through remote e-voting platform of NSDL.
